

Get Your Pants On! Monthly Model Contest Rules

To enter our Get Your Pants On! "Monthly Model Contest":

1. **Contest is open to male and female contestants up to the age of 25.**
2. No entry fee is necessary to participate, but contestants must purchase a shirt or hoodie sweatshirt (style, color and design of their choice) from the Get Your Pants On! website to wear in the photo they submit. www.getyourpantson.com
3. Photographic submissions must be emailed to **contest@getyourpantson.com**.
4. Please make sure the pictures are of good quality and are not blurry. Model should be the only person in the image. This year, you **MUST** upload your images for the Contest. **NUDITY IS UNACCEPTABLE.**
5. GYPO reserves the right to screen all contestant entries and their photographic submissions.
6. GYPO reserves the right to use winner's name, images and likeness for publicity purposes worldwide without additional compensation and without prior notice for one year following completion of judging.
7. In addition to the photo submission, contestants need to fill out the registration form on the website contest page. Personal information on the registration form is for the contest only, and is not sold to, nor shared with anyone for any reason.
8. Contestants may enter the contest in multiple months if they purchase and model additional shirts.
9. Photos must be submitted by the 25th of the month by 12:00 midnight to be eligible for the following month's contest.
10. Any contestant submitting their entry after the 25th of the month will be automatically entered in the next month's contest. Winner will be posted on the Get Your Pants On! Website by the first of the month.
11. Each Monthly Winner's photo will be featured on our website as the **Get Your Pants On! "Model of the Month"** during the duration of the next Contest.
12. At the end of this time period, the Monthly Winner's photo will be moved to our Contest Winners page where it will be permanently featured.
13. The Winner will be notified by phone and email and will be required to complete an Affidavit of Eligibility and Liability/Publicity Release, which must be returned within 5 days of the date on the notification email. If winner is a minor, parent or legal guardian will be required to execute Affidavit. No substitution for prizes except as may be necessary due to unavailability, in which case a prize of equal or greater value will be awarded. Prizes are not transferable or redeemable for cash.
14. **Our Yearly Grand Prize Winner** will be selected from the Monthly Winners for that calendar year to be the Get Your Pants On! model of the year. **Prize package for this will be announced soon!!**
